



**MEMORANDUM OF UNDERSTANDING (MOU)**

**BETWEEN**

**CHINA COUNCIL FOR THE PROMOTION OF INTERNATIONAL TRADE  
HANGZHOU COMMITTEE**

**And**

**GLIWICE REGIONAL CHAMBER OF COMMERCE AND INDUSTRY**

**June 01, 2019**

China Council for the Promotion of International Trade Hangzhou Committee and Gliwice Regional Chamber of Commerce and Industry hereinafter called the "Parties", respectively, signed this MOU to declare their willingness in developing economic and commercial cooperation between each other.

Recognizing immense possibilities of improving economic and commercial ties between China and Poland, in order to facilitate trade and strategic business alliance between both business communities, the Parties have agreed as follows:

#### **Article 1**

The Parties will strongly support each other's promotional trade and investment programs that would be conducted in order to help companies explore strategic partnership options.

#### **Article 2**

In order to further increase trade and investment promotion efforts, the Parties will assist each other to disseminate leads of potential business opportunities to the business organizations and companies.

#### **Article 3**

Parties will assist each other to connect their relevant business organizations to form awareness about business opportunities, trade and investment climate, as well as incentives could be offered.

#### **Article 4**

Parties will mutually support each other to organize business seminars, conferences and road shows to inform companies about the business environment, and encourage both business communities to participate in such endeavors.

#### **Article 5**

Parties shall support information exchange (including investment projects) between companies on both sides; and shall promote communication and cooperation in advantageous fields (such as advanced equipment manufacturing, E-commerce, ICT, bio-medicine, energy-saving, etc) and start-ups & innovation, on both sides.

## Article 6

Parties will communicate to discuss further collaboration areas at mutually agreed times. The meeting format and location will be determined by both parties' representatives.

## Article 7

All cooperative activities under this MOU will be carried out subject to the availability of funds of both parties and in accordance with the laws and regulations of their respective countries.

## Article 8


Whereas this MOU shall not constitute a binding agreement, any difference, which may arise, from its interpretation or application shall be resolved jointly among the parties.

## Article 9

This Memorandum of Understanding comes into force from the date of its signature and shall remain in effect for an indefinite period. The MOU shall be renewable with the consent of both parties and under the condition that one party here gives written notification to the other party at least three months in advance.

This MOU is prepared in two original copies in English language with the same legal effect signed by each Party's duly authorized representative on June 01, 2019 in Krakow, Poland.
